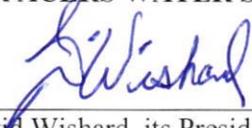
REPORT OF THE PRESIDENT OF THE BOARD OF DIRECTORS

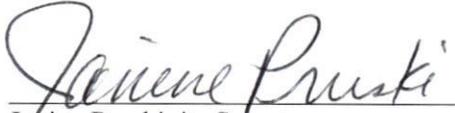
ADJOURN
