## 2023 Base Rate Holiday!

Due to the current financial status of RAWS, the Board of Directors has unanimously approved a one-time Base Rate Holiday for all members.

Your base rate (\$55) will be WAIVED for the January 2023 bills. The changes will be reflected on your bill automatically.

#### **DROUGHT INFORMATION**

As a reminder, RAWS is still under stage 1 of the Drought Contingency Plan (DCP) and will remain in stage 1 until the lake levels reach at least 50% or above.

During this stage, irrigation of landscaped areas with hose end sprinklers or automatic irrigation systems shall be limited to once per week. Your designated water day is the same day as your trash pick up day.

Secondly, the use of water to maintain integrity of building foundation is limited to designated watering days (trash pickup day) and is only permitted by use of handheld or drip irrigation. Also, please be aware within our RAWS community and report any potential leaks or excessive uses that can be corrected or fixed as soon as possible.

By working together, we can all do our part to conserve as much water as possible during these tough times in our environment.
