#### DROUGHT RESTRICTIONS

Restrictions for Stage 3 are as follows:

1 - Irrigation of landscaped areas shall be **prohibited at all times.** 

2 – Use of water to wash any motor vehicle, motorbike, boat, trailer, or other vehicle not occurring on the premises of a commercial car wash station and not in the immediate interest of public health, safety and welfare is prohibited.

3 – Filling, refilling, or adding water to swimming pools, wading pools and jacuzzi-type pools, and water parks (unless non-city, alternative source) is prohibited (you may add water to your pool to protect the integrity of the pump system as needed)

4 – The use of water to maintain the integrity of a building foundation is still permitted on the designated Stage 2 watering day (every other week on trash pickup day) and shall be done by hand or drip irrigation method.

5 – All fountains shall only operate to circulate water to maintain equipment.
